- b) Please check with your Trane/American Standard parts distributor or the Trane Parts Center to see if the defective part must be returned for warranty credit.
- c) For Residential Evaporator Coils, 5 tons and less must be returned by ALL dealers
- d) Exceptions are limited to the following:
 - Heat exchangers are entirely exempt unless under Mandatory Return to Headquarters.
 - For all compressor claims **not** under Mandatory Return to Headquarters return ONLY the nameplate with the WCR form (Compressor not required).
 - For **condenser** coils, only the manifold assembly (including some of the spine fin on at least one of the connecting tubes) is required.
